THREE SOUTH END YOUNG PEOPLE HURT

Miss Lena Gooch, 16-year-old daughter of Mr. and Mrs. Luther Gooch, of Kings Mountain, suffered a fractured skull and is in a critical condition in the Danville Hospital; Miss Lola Jenkins, 12, daughter of Squire and Mrs. J. Harvey Jenkins, of the Pleasant Point section, was thrown between the foot walk and the railroad tracks and was saved from possible death in Kentucky river, 300 feet below, by Arch Rogers, 15, of Kings Mountain, who seized her wrist and held her until the train had passed, and suffered a fractured jawbone, and Eskar Hubbard, 20, son of Mr. and Mrs. M. B. Hubbard, of Kings Mountain, is in the Danville hospital being treated for scalp wounds and bruises. The young people were members of a Sunday school picnic party and were spending Saturday at High Bridge. The train, the Royal Palm, passed while they were on the bridge and it is claimed a metal rod projecting from the train was the cause of the accident that came near resulting fatally to one or more of those who were injured. Miss Lucy Irene Vanover, 18, is said to have escaped injury by dodging the projection, which barely grazed her shoulder.
